Telemedicine and electronic health records are making inroads, but the need to communicate clearly with patients, and to accurately record and securely protect their medical information, remains as important as ever. This course will examine the impact of new laws and technologies on doctors and patients. This activity is intended for all Physicians, Podiatrists, and Dentists. There are no prerequisites.

Objectives: Doctors will learn to: identify criteria for evaluating technological effects on communication; Develop strategies for preserving good communication while using new technologies, or identify alternatives to using those technologies.; Identify criteria for evaluating technological effects on privacy; Develop strategies for preserving privacy while using new technologies, or identify alternatives to using those technologies; Analyze the emerging research and case law, in order to decide if there is a suitable role for telemedicine within ones practice; Plan and design an EHR system that maximized clinical benefits in addition to being compliant; Analyze evidence on telemedicine and EHR, then formulate positions on technology and express in a persuasive way.
